- ⇒ No person shall sell, offer for sale, distribute or use any "confetti" or other substance of like nature on the public streets. The intent and purpose of this law is to prevent persons from pelting one another or the public within the city with the aforementioned substances.
- ⇒ No person shall loiter in or about the Wayne County Morgue in the City of Detroit.
- ⇒ No person shall fire a canyon in any public street, avenue, alley, park or other public place without first having obtained a written permit from the mayor, which permit shall only be granted when it shall appear to the mayor that such firing is to be done under the supervision of experienced gunners.
- ⇒ No person may consume more than three sips of beer at a time if they are standing up.
- ⇒ It is illegal to get a fish drunk.

What Not To Say When Pulled Over By A Police Officer

Citizens who are generally law-abiding are likely to come into contact with the police for one reason: If you get pulled over for a traffic violation. This is not to say that you are more than pleased when you do get pulled over, however, with a few exceptions, police officers are not mandated to write tickets, and if in fact you handle the situation in a friendly manner you may save yourself both time and money. Here are a few rules you should follow if you find yourself being pulled over:

- ◆ Do Not Argue
- ◆ Keep It Honest
- ◆ Stay Calm

Police officers are trained to note the human characteristics of lying, including twitching and looking to the left, and they know the right questions to ask to reveal the truth. "All we do is react to what people do when you pull them over. The situation will escalate or de-escalate depending on how that person reacts," says Dennis Fanning, Veteran L.A. police officer.
